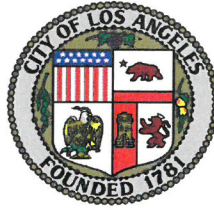

SUBJECT: Quick Reference and Ballot Measure Calendars for the City of Los Angeles' 2017 Primary and General Elections

For your future use, I have attached copies of the 2017 Quick Reference Calendar and Ballot Measure Calendars for the **City of Los Angeles' 2017 Primary Nominating and General Municipal elections**. These calendars list legal and practical deadlines for activities related to placing measures onto those upcoming elections.

As a reminder, these dates are intended for reference purposes only. Some of the future Council Recess dates are tentative.

Also please be aware that, with few noted exceptions, we have listed the *legal* (absolute) deadlines. Thus it is advisable to schedule activities well in advance of these dates so that deadlines are not missed due to Council Recess, inclement weather or other unscheduled events.

ELECTION EVENT QUICK REFERENCE CALENDAR LEGAL DEADLINES FOR CITY OF LOS ANGELES 2017 ELECTIONS

These are key election calendar events and their corresponding dates. Some events reflect the practical deadlines, which may differ from the statutory deadlines, as explained in the footnotes. It is advisable to schedule activities well in advance of the dates listed to avoid the possibility of missing the deadline.

¹The deadline for this Council action is one Council meeting before the meeting at which the Council adopts the resolution placing a proposed bond measure on the ballot.

²The legal deadline of E-110 (11/17/16) falls during Council Recess. Therefore, the deadline is moved to the week preceding the recess.

³The legal deadline of E-110 (1/26/17) falls on a Thursday, which is not a regularly scheduled Council meeting day. Therefore, the practical deadline becomes the preceding Wednesday.

⁴The legal deadline of E-85 (02/20/17) falls on a holiday, therefore, the deadline is extended to the following day.

⁵The legal deadline of E-64 (01/02/17) falls on a holiday, therefore, the deadline is extended to the following day [Charter Section 106 (a)].

⁶The legal deadline of E-15 falls on a holiday, therefore, the deadline is extended to the following day.
